and reporting for multiple regulatory agencies. Data only needs to be entered once and is manipulated to fit all of the organization's requirements:

- Title V
- Discharge Monitoring Report (DMR)
- Infectious and hazardous waste tracking
- FDA's current Good Manufacturing Practice (cGMP)
- Sustainability and annual shareholder reporting
- Green reporting in Canada

Because the organization had limited personnel resources in the environmental, health and safety (EHS) department, Sanofi Pasteur began looking at compliance management systems to streamline processes, improve data quality and save time. The Enviance System was initially used to automate fuel permit calculations on an hourly basis.
